The Montgomery City Council, at its regular meeting held on Monday, August 21, 2023, approved Ordinance No. 4-2023 adding a new section to Chapter 5 of the Montgomery City Code regarding the registration of cannabis and cannabis related products including low dose THC infused edibles and beverages.

### **City of Montgomery Ordinance No. 4-2023**

The City Council of the City of Montgomery, Minnesota, hereby ordains that the City adopts Chapter 5, Section 505 of the Montgomery City Code related to the registration for businesses selling cannabis, cannabis related products, including low dose THC infused edibles and beverages. The section includes definitions, limits on registrations per 12,500 population, compliance checks, time of sale, and other regulations consistent with Minnesota Statute 342.

### **City of Montgomery Ordinance No. 5-2023**

The City Council of the City of Montgomery, Minnesota, hereby ordains that the City amend Chapter 11, Section 1115 of the Montgomery City Code related to permitted and accessory uses within zoning districts of the City, to allow the sale of low dose THC infused edibles and beverages in commercial districts - B-1, B-2, and B-3 as an accessory to the primary business.

### **City of Montgomery Ordinance No. 6-2023**

The City Council of the City of Montgomery, Minnesota, hereby ordains that the City amend Chapter 10, Section 1050 of the Montgomery City Code related to rules and regulations on public and private property, to prohibit the consumption of cannabis and cannabis related products, including low dose THC infused edibles and beverages in public spaces, as defined in 1050.01 subd. 5 to include parks, sidewalks, trails, public streets, etc.
